

SB 678 Data Reporting

Senate Bill 75 made changes to the SB 678 program including the addition of new data collection requirements. Pursuant to Penal Code § 1231(d), in addition to data regarding felony probationers, the Administrative Office of the Courts (AOC) will also collect data on individuals supervised on post release community supervision (PRCS) and mandatory supervision. The table below contains all data points the AOC must collect quarterly with new data points highlighted in yellow.

If an individual is on multiple supervision types the following hierarchy should be used:

- 1) Felony probation
- 2) Mandatory supervision
- 3) PRCS

For example, if an individual is on both felony probation and PRCS they should be counted in all data points regarding felony probation and should be excluded from all data points regarding PRCS. Please note that this hierarchy is different than the hierarchy used by CPOC.

16	New Probation Grants	Count of all individuals who were granted probation on a new felony case.	Currently report.
17	New Mandatory Supervision Grants	Count of all individuals who started a mandatory supervision term during the quarter. * Please note that this is different from the CPOC definition. This is the number of individuals who started supervision during the quarter. It is <i>not</i> the number of individuals <i>sentenced</i> to mandatory supervision in the quarter.	This data point will be included in the online data reporting tool for Q3 2013.
18	PRCS Releases	Count of all individuals who were placed on PRCS during the quarter.	This data point will be included in the online data reporting tool for Q3 2013.
